A new Open Space (OS) Zone is being proposed for those lands within the Town that are used or intended for passive open spaces uses, such as trails and conservation projects.

Planning Staff is recommending that the application be deferred to allow Town and County staff to undertake a final review of the amendment prior to submitting same to Council for their consideration.
