1. Relief from the provisions of **Section 16.1, Table 16.1 – Uses Permitted**; to increase the maximum gross floor area for a place of worship from 650 m2 (7,000 ft2) to 1,097.8 m2 (11,816.6 ft2) to facilitate the construction of an addition to the existing place of worship.

The proposed relief meets the four tests of a minor variance as set out in Section 45(1) of the Planning Act as follows:

The proposed relief is a minor variance from the provisions of the Town of Ingersoll Zoning Bylaw in that the proposed addition is a minor expansion to an existing legal non-conforming place of worship;

The proposed relief is desirable for the use of the land as the said relief will allow for an place of worship that is permitted by the Zoning By-law, is compatible with surrounding uses and will not negatively impact neighbouring properties;

The proposed relief maintains the general intent and purpose of the Town of Ingersoll Zoning By-law as the development generally maintains the provisions in the IN1 zone and is in-keeping with similar development in the immediate area; and

The relief maintains the intent and purpose of the Official Plan as the use of the lands for a place of worship is contemplated within the low density residential development by the Official Plan.

**AND WHEREAS** the Supplier has requested that the Council indicate, by a resolution dated no earlier than June 10, 2015 (the "New Resolution"), Council's continued support for the construction and operation of the Project on the Lands;

**AND WHEREAS** where a New Resolution is received in respect of a Project, the Supplier will be recognized as fulfilling the requirements under Section 2.4(d)(vii) of the FIT Contract, which may result in the Supplier being offered Notice to Proceed in accordance with the terms of the Supplier's FIT Contract;

## NOW THEREFORE BE IT RESOLVED THAT:

Council of the <u>Town of Ingersoll</u> supports the construction and operation of the Project on the Lands.

This resolution's sole purpose is to enable the Supplier to achieve Notice to Proceed under its FIT Contract and may not be used for the purpose of any other form of municipal approval in relation to the FIT Contract or Project or for any other purpose.
